Among the highlights of the ACRL National Conference was waking up Saturday morning to a light dusting of March snow over Denver. The cloud-covered Rockies and cold wind encouraged brisk morning walks to the Colorado Convention Center. The theme of the conference "ACRL X: Crossing the Divide" provided a focus for numerous roundtables, workshops, panel discussions, papers, poster sessions, and challenging speakers. With an attendance of over 2000 colleagues and almost 200 exhibitors, the conference embraced the new millennium with energy and enthusiasm.

Some of the sessions I attended included assessment of student learning, scholarly communication, "libraries as pockets of hope," collegial leadership, bridging the information literacy divide, a conversation with Clifford Lynch on emerging technology and policy trends, and digital reference. Other program titles included such phrases as "technology revolution," "digital dilemmas," "personalized research clinics," "web portals," "campus library partnerships," "herding fish and corralling cats," "critical thinking," "successful librarian-faculty collaborations," "entrepreneurial library," "nailing jell-o to the wall," "downloading detectives," and "postmodern library." Board Meeting Minutes

March 23, 2001
Ellensburg, Washington

Charles called the meeting to order.

ACRL Chapters Council Meeting

Lynn attended the ALA/ACRL Chapters Council at the Midwinter Conference of the American Library Association in Washington, DC in January 2001. ACRL has encouraged local chapters growth since the late 1970's and the Council is a mechanism for the local chapters to get together and share information amongst the chapters. It is also a good opportunity for the National ACRL organization to share information from their perspective and to hear from the local chapters. Approximately 75% of the chapters had representatives at the meeting. Updates were provided on current legislation and candidates for National ACRL offices were introduced.

The biggest concern was how to improve communication. The northwest ACRL list could be used more actively to disseminate information. The National ACRL website has links for all local chapters as well.

A discussion followed on who should represent the Washington chapter at future ALA conferences. Some chapters specify a member to attend in their bylaws. It is

very helpful to have a chapter's representative attend for a three-year cycle if possible. It was decided that Lynn will attend future meetings and that the chapter would leave it open for the Board to decide in the future for flexibility.

We haven't been contributing regularly to Chapter Topics. Charles volunteered to prepare future contributions.

Our chapter is eligible to apply to the National ACRL for a speaker to attend a future conference. It will be one of the National ACRL officers and they will pay \$750 towards expenses. Lynn volunteered to process a request for the Pack Forest 2001 conference by June.

Pack Forest Conference Planning

Lynn discussed the status of the fall conference planning. The Pack Forest facility was reserved during the 1999 conference. Charles will contact the Pack Forest office to confirm the dates and to get a copy of our contract. A discussion followed regarding the topic for the 2001 conference. There were nominations of topics from the list serv: Challenges of the Digital Library, Digital Reference, UCITA, Internet Filtering, Archiving of serials, Digitization of Special Collections, E-Reserves, Scholarly Communication, and ILL Digital Delivery. Lynn will post these choices to the list serv and solicit recommendations.

It was pointed out that a good way to save money is to bring our own snacks and audiovisual equipment. Advertising venues were discussed. Carol Svensson, Dal Symes, Esther Sunday, Andrea Kueter have volunteered to help with the conference.

Treasurer's Report

Due to the balance of the account and no upcoming immediate expenses, it was decided that a six-month certificate of deposit for \$4000 should be purchased immediately. Kathleen will arrange this through the Bank of America where the Chapter has its bank account.

Bylaws Revision/Board of Directors Position Descriptions

Brenda and committee members Gary Menges, Andrea Kueter, Jen Stevens and Rosemary Streatfeild have completed the bylaws revision process and have a proposed revision ready for chapter approval. The Bylaws were last revised in July 1989. Some of the issues reviewed included:

- The nature of national ACRL members who do not pay Chapter dues. It was decided that only individuals paying Chapter dues will be considered members of the Washington Chapter.
- The requirement that the president-elect and president must be National ACRL members.
- The requirement to hold both a fall and spring business meeting was amended to only a fall business meeting.
- Chapter communication will take place both in written and electronic formats.
- Deletion of responsibility for vice-president elected every third year to serve a three-year term as the chapter representative to WLA Legislative Planning Committee.
- The appointed positions of Newsletter Editor and Webmaster should be voting members of the Board.

The Webmaster term was set at three years in length.

The dates for the Nominations Committee's work will be redrafted before the revision is sent out.

The Board also reviewed the updated position descriptions for Board members. The committee did a very thorough job of updating and revising individual position

tasks. It was decided that members-at-large will serve on the conference planning committee.

The Board thanked Brenda and the Bylaws Committee for all their hard work on both the bylaws and position descriptions.

The revised bylaws will be mailed with the ballots in the next few weeks. [That was what was decided at the time, later changed.]

Nominations

Lori Ricigliano has chaired the committee and has a slate of two candidates for the member-at-large position. Kelly McHenry has agreed to be on the ballot as vice-president/president-elect. The committee expressed concern about the difficulty it encountered finding candidates for the vice-president position as has past nominations committees. It was suggested that the chapter develop a membership brochure to expand knowledge of the section and hopefully attract individuals willing to run for Board positions.

Liability Insurance

The chapter has discussed the need to purchase liability insurance now that the section has incorporated. At the fall meeting it was decided to purchase the insurance from American States, a division of Safeco. Kathleen has been in contact with Bob Davenport and should be receiving the policy within the month. The yearly premium is approximately \$250 for:

- Employer's contingent liability - \$2 million
- Commercial general liability - \$2 million

Spring Conference

The Chapter has in the past offered a pre-conference at the Washington Library Association's spring conference. In the recent past, attendance by academic librarians at WLA has been down substantially and the chapter has foregone offering a pre-conference. Various ideas were discussed about options for future spring events, including offering a pre-conference in even years - the year that we're not responsible for the fall conference. The topic will be reviewed again at a future Board meeting.

Charles adjourned the meeting.

A discussion followed regarding liability insurance. Rates and information that had been gathered a year ago were reported. Kathleen O'Connor will get updated information. An option that was discussed was to post a disclaimer for events, rather than obtaining insurance. Discussion followed. Considering that the rates are very reasonable and that posting a disclaimer could be risky because it is easy to prove negligence, it was moved and approved that we purchase insurance for the chapter through the American States division of Safeco Insurance.

Two members from the Oregon Chapter visited the meeting and briefed members on the important issue of USCITA legislation that could potentially have a dramatic impact on the balance between consumer and publisher rights. ALA is asking members to become aware of the issues and contact state legislators and their State Attorney General's office and express their concerns particularly in terms of uses by libraries.

Lynn Chmelir, Vice President/President Elect began a discussion on conference planning for next fall. Dates were selected a year ago and they are at the typical time in October. The issue of moving the conference from Pack Forest to another location was discussed. One site suggested was Sleeping Lady near Leavenworth. It was pointed out that for Oregon people meeting in Leavenworth would add 3 hours driving time to attend the conference. Lynn asked that program ideas for next year should be directed to her as well as names of people who are interested in

volunteering. Kathleen will try to find past conference evaluations in the chapter files. ACRL National just conducted a survey and included questions on current topics of interest to the membership. Betsy will send us a copy. A possible program topic is "how do we get instruction to distance learners"?

Besides the Bylaws, Board member responsibilities also need to be updated. Board members will be doing this before the spring Board meeting.

Charles asked for 3 volunteers to serve as a nominations committee.

Over the past years, the Chapter has done different things for a spring conference, including a preconference at WLA. There are a lot of options that could be considered but we need to realize that there are many conferences available vying for attention. The question was raised if the Chapter can be a viable organization if we only offer a conference every other year. The question was raised if we should consider becoming a joint chapter with Oregon. No decision was determined.

Linda Pierce spoke as representative of the Library Council of Washington. The Council's main task is to provide guidance for LSAT funds. This year there is over a million dollars available. More information on how to apply is on the State Library's Web page. In the past academic libraries have been underrepresented and the Council is hoping to encourage a broader base of types of libraries participating. Linda encouraged people to consider statewide projects that need funding and that they can range from \$5,000 and up. A new funding cycle has just started and private institutions are eligible. The State Library's website also has information on Continuing Education grants, which are due in December. Linda offered to be of assistance to anyone interested in pursuing a grant.

John Popko reported on the Swimming Upstream symposium on preservation. Gary Menges got NEH regional cooperation for document preservation. One-day meetings followed scanning school, and UW and UO had a one-day conference that summed up regional conservation models. There seems to be agreement that the best model for the Pacific NW is a single preservation center like New England. Normandy Helmer and Gary Menges are coordinating a pre-steering committee and it is hoped a committee will begin to work in January 2001. It was pointed out that preservation issues do not affect only academic libraries. For example, there are many important county records that need preservation.

A motion to adjourn the meeting was made, seconded and passed. The meeting was adjourned and the members joined the Oregon members for the annual party.

The Future Ain't What it Used to Be

Lizabeth (Betsy) Wilson, ACRL President and Director of University of Washington Libraries

At midnight on December 31, 2000, Betty Bengtson and I metaphorically clinked glasses. She retired after 10 transformative years as director of the University Libraries, and I began my tenure as the new director.

In cleaning out files I found a yellowing booklet entitled *Five Objectives of a University Library*, by William E. Henry, UW librarian in 1927. Reflecting on 30 years in a university library, Henry concludes that the purpose of a university library is "to put the individual of the present in possession of the experience of the past in whatever line he may select and for the final good of the future." I intend to heed his advice.

The future of the academic library is inseparable from the future of the university, and we will be measured by how well our university manages its knowledge. We will need to advance knowledge and educate students for a future we can't even begin to imagine.

As that wise sage Yogi Berra once said, "The future ain't what it used to be."

As I envision our future, you will have access to information when, where, and how you need it, and it will be preserved for generations to come. Our physical and virtual spaces will be trusted and robust.

Four areas are of critical importance as we build the library of the future: scholarly communication, digital libraries, information literacy, and collaboration.

Scholarly Communication. Major changes in scholarly communication are taking place--electronic publishing, sharply escalating prices for journals, modified copyright law and intellectual property protection, and the rise of alternative distribution methods that compete with expensive commercial ones. The promise of the digital revolution has been threatened by commercial publishers intent on maximizing revenues by raising prices and restricting access. We know that we can't buy all the materials that you need. We have worked hard to supplement purchases with interlibrary loan programs and document delivery, but the current system of scholarly communication must evolve.

Digital Libraries. The Libraries has been building a digital library for nearly a decade. You use it every day through the electronic indexes, abstracts, and databases; electronic reserves; the Information Gateway; HealthLinks; and the myriad scholarly websites.

More recently, the Libraries has taken on an expanded role as publisher. We have scanned and indexed unique materials and have made them accessible to audiences worldwide. We will continue building a digital library that will enhance research, transform learning, and allow generations to talk across time in the library of the future.

Information Literacy. Today's graduates may be the first generation "overexposed" to the huge amounts of information available to them. In a perfect world, this would allow us to revel in its diversity. However, in the real world, overexposure only underscores the complexity of the information world and highlights inadequate research skills.

If our graduates are to prosper in the global information society, it is critical that they be able to locate, evaluate, and use information. Although the Libraries is a national leader in information literacy, there is much more that needs to be done by all of us.

Collaboration. Collaboration grows more important every day. There are fewer and

I have very high expectations for the UW Libraries. The possibilities are almost limitless, but creating a preferred future will not be easy.

You have an important role to play in realizing this future. As authors or editors you can help effect positive change in scholarly communication. As educators you can share responsibility for the information literacy of students. As creators of new knowledge you can help build a digital library that has meaning. I invite you to join me in shaping a library of the future that we will all value, others will emulate, and of which William Henry would be proud.

The future ain't what it used to be, but it is ours to determine.

What has 7 libraries, 10 million items and thousands of happy users? If you guessed Cascade you guessed right! If you didn't guess Cascade then read on. The Washington State Cooperative Library Project (WSCLP) introduced Cascade this past July. Cascade is the joint catalog of the libraries of the 6 public baccalaureate institutions here in Washington State: Central Washington University, Eastern Washington University, The Evergreen State College, University of Washington (including the UW Law Library), Washington State University, and Western Washington University.

Anyone may search Cascade and see the holdings in these libraries, <http://cascade.lib.washington.edu>. Cascade is a tremendous resource discovery tool since there are over 6 million records, representing over 10 million volumes. In addition to being able to see holdings across institutions, Cascade allows the faculty, staff and students of the participating institutions to request materials from one library be sent to them at their campus library. Authorized users can also go directly to one of the member libraries and check items out in person. People who don't have requesting privileges in Cascade still can use the information to place traditional interlibrary loan requests with their local library.

One may search Cascade by author, title, subjects and keywords. Searches can be limited by publication year, type of material, language, library location and other ways. There is also a Search Journals Only option to limit the search to the titles of journals (this does not search article titles). There are two paths people can take to search Cascade.

Path 1

A person may begin searching in their home institution's catalog and then repeat the search in the Cascade.

- From the UW libraries catalog (<http://catalog.lib.washington.edu/search~>)
- User is searching for a book with the title "[Dark Life](#)".
- The catalog shows that there is [no such title at the UW](#).
- User can click on the REPEAT SEARCH IN CASCADE button and the search is automatically redone in CASCADE.
- CASCADE indicates that [3 CASCADE libraries have this item](#).
- By clicking on this message the person can [display the libraries that own the item and the status of each copy](#).
- A valid borrower would be able to click on the Request this Item link and have the item sent to them at their home institution.

Path 2

A person may begin their searching at Cascade and be able to identify materials across the institutions/state. Valid borrowers are able to request not only materials available at other libraries but also materials available at their own institutions.

The success of Cascade is evident in the number of requests to the system; over 23,000 items have been requested by patrons since July, 2000. Professor David Secord, of the University of Washington Tacoma, made the following comments about his experience with using Cascade.

"Cascade has been tremendously useful for compiling literature relevant to my research in biology. I had always assumed that virtually any resource one could want would be available in the UW library system. Not so! Repeating searches in Cascade has consistently yielded interesting and relevant books, monographs, theses, and other sources available in Washington State but not at UW. This is a great way to increase faculty and student access to the rich array of resources

held by Washington's many fine university libraries."

Cascade was nearly ten years in the making and is just one of the results of the efforts of the Washington State Cooperative Library Project. In the early 1990s the provosts, librarians, and computing technology specialists of the state's public baccalaureate institutions began, under the sponsorship of the Council of Presidents, to develop a vision for a cooperative library project. The purpose of the project was to enable easy sharing of library resources among the six institutions, their various branch campuses and centers, and their distance learning students throughout the state. In partnership with the State Legislature, a phased project was created and funded in the 1995, 1996 and 1998 supplemental budgets. So far the project has accomplished the following:

- All six public baccalaureate institutions now have up-to-date, integrated library software that provides online catalogs and allows for effective management of the acquisition and circulation of print, multi-media and electronic resources.
- The libraries' photocopy and fax equipment were upgraded, allowing for greatly improved interlibrary loan responses to user requests.
- Improved telecommunications capacity expanded users' access to Internet resources and made this project's continuing development possible.
- The libraries built a joint catalog that is updated continually. A library user may search the holdings of the libraries of all six institutions by entering a single search. Before this joint catalog was created, users had to search each library's catalog separately.
- Nearly all of the remaining card catalog records at each institution were converted to electronic form, making them available through this project to every user, inside and outside the libraries.
- The libraries jointly licensed a large electronic database representing a core set of general-purpose, full text periodicals.
- In 2000, the libraries installed new software that allows a student at any one of the campuses to check out books electronically from any of the other libraries and to have the books delivered to him or her within 72 hours. The new service is a component of "Cascade," the joint, web-based catalog of all six institutions that was implemented in July 2000.

As a result of these efforts, on-campus and distance education students now have more efficient and more effective access to information in its many forms. Some of this information is located in the libraries; some of it is beyond the libraries in computer networks. Much of it now can be accessed electronically.

I was appointed in January as Coordinator for the WSCLP. My responsibilities include working with staff at each site to insure the smooth operations of the Cascade catalog and borrowing. I also work with the Directors to explore the possibilities for extending service beyond the current community. I invite you to explore Cascade for yourself. Students can use their laptops virtually anywhere in the library while connected to the campus network and the Internet. We currently have five wireless network cards available for checkout, and this quarter they have been in constant demand.

The second benefit of wireless is that we have been able to place computers in convenient locations for catalog and electronic database access, where installing network wiring would have been very difficult. We now have computers on all four floors for catalog access and Web research.

Our wireless access points are Apple Airports, which comply with the 802.11b

standard and cost less than \$300. Our wireless network cards are Lucent Technologies WaveLAN, which work in PC, Mac, Linux, as well as other operating systems. The new cards cost approximately \$150 each.


